# 3.1 Maintenance and post sale support services and duration included in installation price:

A three month installation warranty is offered as a standard with all our installations. This warranty covers call outs and repairs at no additional cost.

Mastrone Technique only installs components with a minimum warranty of one year. These warranties cover the replacement of the components as stipulated by the respective manufacturers for the duration of a year should it be necessary.

# 3.2 Maintenance and post sale support services and duration included at additional cost and extended warranty options:

A maintenance contract is available.

We have provided a copy of the contract which stipulates what will be covered by it. The duration of this contract is a minimum of 12 months and a maximum of 24 months. No extended warranty options are offered by Mastrone Technique or the respective manufacturers of components installed by us.

### 3.3 Warranty period for entire installed system:

We offer a 3 month warranty on installation and 1 year on components as stipulated by the respective manufacturers.
